# REPORT OF THE MINE ACTION CO-ORDINATION CENTRE, SOUTH LEBANON for the MONTHS OF JANUARY & FEBRUARY 2006

#### **GENERAL**

- 1. During the months of January and February clearance operations continued but slowly due to bad weather. Several AP and AT were destroyed mainly in the village of Marun Ar Ras adjacent to the Blue Line.
- 2. MACC SL completed and distributed in both English and Arabic versions the Annual Report 2005. In future, all such key reports will now be produced in Arabic.
- 3. The Finance & Administration Officer, Mr. Johan Smith left the MACC SL on the 16<sup>th</sup> of January and his replacement Mr. Pehr Lodhammar arrived on the 9<sup>th</sup> of January. MACC SL recognizes the hard work of Mr. Smith and wishes him the best in his new position with UNOPS in New York.

#### **National Demining Office**

- 4. The NDO Director Brigadier General Raad has left the NDO, and his new replacement is Col Mohamad Fehmi.
- 5. The GICHD conducted training about Explosive Ordnance Disposal Information System (EOD IS) from 14 February till 23. MACC SL Information Officer along with the Ops Officer attended the training held at the NDO in Beirut.

#### UNIFIL, Demining Co-ordination Cell, OGL

- 6. The rotation of DCC has taken place with the new officers taking up their posts pending the withdrawal of all Ukrainian personnel from the UNIFIL Mission. The planned date for the repatriation of DCC and UKRBATT personnel/equipment from Lebanon will commence 10 Mar with the final group departing by 28 Mar.
- 7. The Chinese have offered to replace UKRBATT in its entirety, however at this time the replacement demining component has yet to be decided. The UNMACC Chief of Operations will participate in the Pre-Deployment Visit (PDV) to China (26 Feb 4 Mar) in order to conduct a full evaluation of the proposed Chinese demining equipment, procedures and general conformity in regard to compliance with IMAS. Upon completion of the PDV, a comprehensive report will be produced with details

- of this demining assessment. Based on this report DPKO will decide if the Chinese will replace the UKRBATT demining component or other options pursued.
- 8. In the interim, the UKRBATT demining teams continue clearance in support of UNIFIL and OGL operations. The UNMACC will ensure all minefield documentation is complete prior to their repatriation.
- 9. The UNMACC has been in discussions with OGL in order to provide readily available accurate up to date mine information to the various OGL Patrol Bases. This will be in the form of maps and providing each Patrol Base with a read only access to the Information Management System for Mine Action (IMSMA) database. The UNMACC will provide training to ensure the OGL officers are familiar with the use of IMSMA and will also regularly update the databases at each team site.

#### **VISITS/TRAINING**

- 10. The Chief of Ops attended the pilot Mine Action Technical Advisors Course in the UK at the Defence Academy (Cranfield University) from 8<sup>th</sup> till 21<sup>st</sup> of January.
- 11. Two Swedish interns arrived to MACC SL for training in the end of February. Both will spend four days with each section for introduction briefs and training. After that, one of the interns will spend 3 months with the Public Information Section, and the second with the Finance & Admin Officer for the same period.
- 12. The Chief of Ops gave a Landmine Safety Brief to all current UNIFIL Liaison Branch Officers on 21 Feb. Arrangements have now been made for all new Liaison Branch Officers to be included with the monthly Landmine Safety Brief given by the UNMACC to new OGL officers upon arrival in the mission.
- 13. A group from NPA involved in potential clearance of Israeli minefields along the Jordan/Israel border visited MACC SL and were briefed on the 5<sup>th</sup> & 6<sup>th</sup> of January about MACC SL reconnaissance of Israeli minefields, tasking and clearance methods.
- 14. The LMRC and Mines Action Canada prepared a joint workshop about "Working with You in Mine Action" from 16<sup>th</sup> of January till the 20<sup>th</sup>; MACC SL Programme Manager along with Programme Information Officer attended the workshop, as well as the participation of one of MACC SL CLOs during the field visit to Jezzine area.
- 15. As the rotation of DCC officers is taking place, UN PM gave a brief for the new DCC Officer, Col. Zubarevsky on the 18<sup>th</sup> of January. He was briefed on MACC SL and the Mine/UXO situation in South Lebanon.
- 16. The briefs for OGL continued during this period; MACC SL Planning Officer gave a brief on the 16<sup>th</sup> of January and Chief of Ops on the 20<sup>th</sup> of February regarding Landmine Safety and Mine/UXO situation in South Lebanon.
- 17. Mr. Phil Bean, head of IMAS in GICHD, visited MACC SL on the 25<sup>th</sup> of January. During his visit, he was briefed about the QA Process, the Management of OES and TSGs adopted by MACC SL.
- 18. Miss Amanda Burns, from MAG HQ, visited the MACC SL on the 27<sup>th</sup> January, she attended the coordination meeting, and met with UN PM where she was briefed about MACC SL work. She also conveyed thanks from MAG HQ regarding the

- \$6000 raised during DMA and presented to MAG Lebanon. The money will be allocated to support spare parts for the MAG MineCat flail.
- 19. Stewart Henley visited the LAF Survey Team in Marun Ar Ras 26 January to evaluate the teams metal detector (CEIA) drills and assessed they were all competent.

#### PROPOSED AREA 6

- 20. The overall area is now broken down into six separate, sub-sectors, that may be operationalised individually or all at once. The new Lebanese government has now begun formal representation to various GCC countries to secure the necessary funding assistance to complete clearance of this remaining mine/UXO contaminated area in South Lebanon.
- 21. The concept note prepared by MACC SL and UNDP Socio-economic Rehabilitation Programme for South Lebanon for a proposed demining and socio-economic rehabilitation project in South Lebanon supported by the Japanese supported, United Nations Human Security Trust Fund (UNHSTF) has been approved and UN HQ are now working on submission of the full Proposal document. It is hoped to be able to implement this much-needed project in the coming months.

#### **OPERATIONAL CAPACITY**

#### **Mines Advisory Group (MAG)**

- 22. The MAG Technical Operations Manager, Mr Nick Guest left Lebanon on 20 Jan as he was posted to the MAG programme in Sudan. During his time of over one year in Lebanon Mr Guest enhanced the very good working relationship between MAG and the MACC SL. The staff of MACC SL wish Mr Guest all the very best in Sudan. His replacement Mr Andy Gleeson is expected in country mid Apr 06.
- 23. A new Technical Field Manager (TFM) for MAG, Mr Magnus Rondstrum has arrived. He worked for MAG previously in Lebanon in 2003 and has returned to provide training and supervision for the additional manual clearance team MAG is establishing. The preparations for this are in the final stages with the new team expected to be operational by Jun 06.
- 24. MAG clearance teams continue operations in Area 6 with the manual teams working near the village of Sejoud, Kfar Roummane and Kfar Tebnit. The clearance teams progress in Sejoud has been hindered due to wet weather and snow. Almost all minefields in this task dossier have now been completed. There remains one minefield to locate and four booby traps to clear. New information has been acquired which has resulted in a number of visible AT mines located along the side of a former route used by the IF tanks. The Plans Dept has written a clearance plan for this site and has issued this to MAG.
- 25. The Minecat flail has experienced major problems with various components and has been out of commission for the best part of this reporting period. New

parts have been ordered from Norway and it is expected the machine will be back in operation within the coming week.

#### **LAF Survey/Sampling Team**

26. The LAF Survey Team continues clearance in the village of Marun Ar Ras adjacent to the Blue Line, and have continued to find and destroy a mix of AT and AP mines. The pattern emerging from this minefield is of a conventional pattern with an AT mine (TMA-3 or M7A2) with up to five Mle 51 AP mines in a semi circle around the AT mine. This minefield was laid in the 1970's and therefore the pattern has been some what disrupted in the 30+ years.

#### **Quality Assurance**

- 27. The new MAG TFM successfully passed a joint MACC SL UN/LAF accreditation on 22 Feb. A letter will be forwarded to the NDO recommending a one-month provisional accreditation. Upon four successful QA evaluations a full operational accreditation for twelve months will be issued.
- 28. The MACC SL QA Officers continue with weekly QA evaluations of all clearance sites within the Area of Operations. This currently consists of the LAF Survey Team, the MAG manual clearance teams and MineCat flail as well as the UKRBATT manual clearance teams.

#### **Mine/UXO Clearance Statistics**

29. The clearance results for the period under report are as follows:

Note 1: This is area/land all of which has been physically and systematically processed by a demining organisation to ensure the destruction/removal of all mine/UXO hazards.

Note 2: This figure represents the total land released back to the community through either clearance or "actions other than clearance/cancellation" process.

#### **Public Information**

- 30. On the 17<sup>th</sup> of January 2006, MACC SL presented a brief for students in the American University of Beirut. The briefing was prepared upon request from AUB staff/student after they attended the DMA initiative event and they were curious to know more about the situation of Landmine problem in South Lebanon.
- 31. On the 18<sup>th</sup> of January 2006, the Media & Post Clearance Officer attended the Post Marathon ceremony in which the "Beirut International Marathon organization" presented the achievement of the "BIM" 2005 and thanked all the different parties, which participated and helped to make this success possible.
- 32. MACC SL received two certificates of appreciation from the "Beirut International Marathon organization" and certificates for the volunteers who worked on the refreshment stand on the Marathon day. On the 27<sup>th</sup> of January, MACC SL prepared a celebration and invited "Mines Advisory Group" staff where the PM of the MACC SL delivered for the volunteers their certificates.
- 33. The PM of MAG delivered by his turn to the "DMA initiative" team a letter of gratitude for the fund they provided to MAG which was raised by the launching event of the movement.
- 34. As part of the Media campaign for awareness about the landmines situation in Lebanon, a journalist of Al-Balad newspaper gathered information from the Public Information section at the MACC SL and posted an article about the Mine problem in the South and the work of the MACC SL. Another journalist from "The Voice of Lebanon" radio station conducted an interview with the PM of the MACC SL about the same subject and it was broadcasted on the radio.
- 35. Based on the locals need to use their lands in South Lebanon, representatives of the local communities in Al Nabatiyah, Hasbayya, Jezzine and West Bekaa areas signed a petition asking for Landmine clearance from their villages.

#### **Constraints**

- 38. At present the following constraints are limiting the scale and effectiveness of the operation:
  - a. There are no current operational constraints, although the overall political and security situation in Lebanon remains volatile.

#### **Support Required From UNOPS/UNMAS**

- 39. The following support is requested from UNOPS/UNMAS for March 2006:
  - a. UNMAS to ensure that this Monthly Report is posted on E-mine and distributed at HQ as appropriate.
  - b. UNMAS are requested to continue to seek funds to support a demining capability to work in south Lebanon:

- (1) UNMAS to continue working with UN OCHA regarding the necessary actions/follow up required for the UN Human Security Trust Fund now that the Concept Note has been agreed/approved.
- (2) UNMAS to advocate for continued support for the mine clearance programme in South Lebanon.
- c. UNMAS to follow up the current situation/status of the Recommendations of the DPKO Assessment Visit Report regarding possible options for the replacement of Ukrainian demining elements within UNIFIL.
- d. UNOPS to provide copies of BRIO reports for the year of 2006 through February month.

#### Support Required from the Office of the PRSG

- 40. The following continued support is requested, for the UN Component of MACC SL, from the Office of the Personal Representative of the Secretary General in Lebanon during March 2006:
  - a. Continued overall political guidance regarding the mine action programme and future intentions. (*Note that the mandate of the PRSG now covers all of Lebanon*)
